## Privacy Notice for Darrick Sports

### 1 Introduction

#### *Background*

Due to the data protection laws changing Darrick Wood School requires a new Darrick privacy notice.

#### *Objectives*

To offer customers of Darrick Sports a clear and concise document that informs how we collect, store, use and share their personal data.

### 2 The categories of personal information that we collect, process, hold and share include:

- personal information (such as name, title and contact details)
- special categories of data including characteristics information (such as gender and age)
- relevant medical information (such as disabilities or injuries)

### 3 Why we collect and use this information

We use personal data to:

- To contact and communicate with you
- Complete a membership agreement
- To assess the quality of our services
- To comply with the law regarding data sharing

## 4 The lawful basis on which we use this information

We collect and use personal information under the requirements of the GDPR and the provisions of the Data Protection Act 2018. It is based on guidance published by the Information Commissioner's Office (ICO) on the GDPR.

We only collect and use personal information about you when the law allows us to. Most commonly, we use it where we need to:

- Fulfil a contract we have entered into with you
- Comply with a legal obligation
- Carry out a task in the public interest

Less commonly, we may also use personal information about you where:

- You have given us consent to use it in a certain way
- We need to protect your vital interests (or someone else's interests)

Where you have provided us with consent to use your data, you may withdraw this consent at any time. We will make this clear when requesting your consent, and explain how you go about withdrawing consent if you wish to do so.

Some of the reasons listed above for collecting and using personal information about you overlap, and there may be several grounds which justify the use of your data.

While the majority of information we collect about you is required to provide a service, there is some information that can be provided voluntarily.

## 5 Collecting this information

Whilst the majority of information you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with data protection legislation, we will inform you whether you are required to provide certain personal information to us or if you have a choice in this.

## 6 Storing this information

We hold your data for 7 years from the date of a booking.

We will hold any information regarding your Darrick Sports gym membership for 7 years.

The exceptions to this is safeguarding data that will be kept indefinitely.

## 7 Why we share your information

We do not share your information with anyone without consent unless the law and our policies allow us to do so.

### 7.1 *Our Auditor*

We are required to share information about your letting with our Auditor regularly to conduct reviews and audits to test our privacy measures and make sure we are compliant. Information could also be used to conduct financial reviews.

## 8 Requesting access to your personal data

Under data protection legislation, you have the right to request access to information about you that we hold. To make a request for your personal information, contact:
